**VALLEY TOWNSHIP RESOLUTION
FOR THE ADOPTION AND SUPPORT OF
THE VALLEY TOWNSHIP HISTORICAL COMMITTEE**

**A RESOLUTION SUPPORTING THE ESTABLISHMENT OF
THE VALLEY TOWNSHIP HISTORICAL COMMITTEE**

WHEREAS, the Board of Supervisors of the Township of Valley, Chester County, Pennsylvania, does hereby find as follows:

The establishment of the Valley Township Historical Committee will be a representation of a three to five-member committee which will consist of a Valley Township Board Supervisor and citizens interested in public history from Valley Township. The committee will also have a chairperson, vice chairperson, a secretary, and general committee member(s). The Committee will meet monthly on the third Wednesday of each month and this can be flexible based on members' schedules.

WHEREAS, in accordance with the state and federal law to research, document, promote, record, preserve and protect the historical and architectural value of the properties and history in Valley Township, Chester County, Coatesville, PA;

WHEREAS, to enhance the value and environment of those properties, to foster economic development, civic pride; establish processes, and or procedures to guide and or direct the activities and events of the historical committee.

WHEREAS, in order to facilitate the most efficient and effective remedy to adequately participate as a historical committee in Valley Township, Chester County, Coatesville, PA, establish a sub-committee, or sub-committees for the purpose of identifying historic sites, facts, properties, structures in Valley Township as wells establish a process to acknowledge and celebrate the history of a historic site, fact, property and structure.

WHEREAS, the sub-committees will consist of three or no less than two original members of the historic committee.

WHEREAS, the committee will serve as a review board to seek methods of sustaining the designated historic sites in Valley Township, Chester County, Coatesville, PA.

WHEREAS, this committee will meet on designated monthly dates and conduct an annual meeting as well as biannually meeting. In addition to conducting said meetings, will also provide reports to the Valley Township Board of Supervisors and work with the committee chair to


provide brief update on the committee's progress that will be included at least semi-annually in Public History News.


