MINUTES FOR JANUARY 2, 2018

The regular monthly meeting of the Valley Township Board of Supervisors was held on Tuesday, January 2, 2018, immediately following the Annual Organization Meeting at the Township Municipal Building, 890 West Lincoln Highway, Coatesville, PA.

The meeting was called to order by Chairwoman Patrice Proctor. Those in attendance were Supervisors Christopher Lehenky, Kathy O'Doherty, Eric Lama, Joe Sciandra, and Patrice Proctor. Also in attendance were Ed Rasiul of Pennoni Associates, Inc. (Township Engineer) and Alan J. Jarvis, Esquire (Township Solicitor).

CITIZENS COMMENTS ON THE AGENDA:

None

Mr. Sciandra made a motion to take the agenda out of order. Ms. O'Doherty seconded the motion. Question: Mr. Lehenky – yes; Ms. O'Doherty – yes; Mr. Lama – yes; Mr. Sciandra – yes; Ms. Proctor – yes.

CITIZEN'S COMMENTS:

<u>Darryl Johnson, 122 Mt. Airy Road</u> – Mr. Johnson inquired about connecting to the Valley Township public water system. Mr. Rasiul reviewed two options. The one option, which would run the line through an adjacent property owner's property, would require an easement from the landowner. The other option would require a new main installed. Mr. Rasiul also reviewed the other required documents that would be required for connection. It was requested that Mr. Johnson submit a plan for the Township Engineer's review.

<u>Alexey Tyshko, 729 Meadowbrook Drive</u> – Mr. Tyshko reported that a few years ago, Valley Township paid to replace his pressure reducer valve. He noted that he recently replaced it again and inquired if the Township would reimburse him. Mr. Lehenky noted that the Township records indicate that the Township replaced his valve in 2009 due to a Township pipe repair. The recent replaced would be an expense of the homeowner.

ENGINEER'S REPORT:

Mr. Rasiul read and submitted the engineer's report which is on file at the Township Office.

OLD BUSINESS:

Consideration/discussion to authorize Sucker Run Project bid advertisement to run on January 11 and 15, 2018 with bid opening on February 13, 2018 – **Mr. Lehenky made a motion to approve the bid advertisement schedule for the Sucker Run Project as presented. Mr. Sciandra seconded the motion.** Question: Mr. Lehenky – yes; Ms. O'Doherty – yes; Mr. Lama – yes; Mr. Sciandra – yes; Ms. Proctor – yes.

At this time, Mr. Rasiul departed the meeting.

SOLICITOR'S REPORT:

Attorney Jarvis reported on the following items:

- Mr. Jarvis reported that he recorded the grinder pump agreement for 115 Glencrest Road.
- Mr. Jarvis reported that a meeting with Terry Pirches regarding the temporary and permanent easements for the Sucker Run Stabilization Project was held on today's date.
- Mr. Jarvis reported he received and talked with Craig Lewis of Stewart Kaplan regarding their filing. Mr. Jarvis stated that Mr. Lewis advised that this is a protective appeal to secure Valley Suburban's rights under the 2016 application. He stated that Mr. Lewis advised that he would give the Township at least 60 days to answer the Appeal and/or return the record to the Court should they proceed. Mr. Jarvis requested that the Township receive this in writing.
- Mr. Jarvis reported that he has forwarded copies of the professional fee invoices from August 2016 to current to Art Sagnor as well as the estimated cost for Pennoni to come out and do another inspection. Mr. Jarvis advised Mr. Sagnor that until these costs are paid to the Township, Pennoni will not be instructed to do another inspection.
- Mr. Jarvis reported he will draft the annual Emergency Response Resolution for consideration at the next Board of Supervisors' meeting.
- Mr. Jarvis stated that the Conditional Use Hearing for Lampart Limited Partnership will be held at 7:00 p.m. on January 16. Mr. Cutlip has posted the property, the public notice was prepared and scheduled for advertising, and that his office sent notification letters to adjacent property owners.
- Mr. Jarvis stated that he will require some additional information from Mike Ellis for an easement required for the Manor Road project.

At this time, Mr. Jarvis departed the meeting and Mr. Sciandra stepped out of the meeting.
