MINUTES FROM NOVEMBER 8, 2017

The regular monthly meeting of the Valley Township Board of Supervisors was held on Wednesday, November 8, 2017 at the Valley Township Building, 890 West Lincoln Highway, Coatesville, PA.

The meeting was called to order at 7:54 p.m. by Chairwoman, Patrice Proctor. Those in attendance were Supervisors Christopher Lehenky, Kathy O'Doherty, Eric Lama, and Patrice Proctor. Supervisor Joe Sciandra was absent. Also in attendance were Ed Rasiul of Pennoni Associates, Inc (Township Engineer) and Alan J. Jarvis (Township Solicitor). An executive session was held at 6:30 p.m. prior to the meeting to discuss personnel issues and items on the agenda.

Mr. Lehenky made a motion to take the agenda out of order. Ms. O'Doherty seconded the motion. Question: Mr. Lehenky – yes; Ms. O'Doherty – yes; Mr. Lama – yes; Ms. Proctor – yes.

BOARD GENERAL COMMENTS:

Chairwoman, Patrice Proctor, extended congratulations to the Supervisors re-elected at the November 7, 2017 election.

It was noted the Board of Supervisors would be meeting with John Cunningham, Township litigation attorney, on November 13, 2017 at 6:00 p.m. to discuss the litigation of The Village of Hillview/Orleans (Orleans RH PA-IL, LP vs Valley Township (2017-04086-MJ)/Valley Township vs Orleans RH PA-IL, LP (2017-06089-CT).

There were no citizens present.

OLD BUSINESS:

<u>Discussion/consideration to set a date to meet with residents of Burgundy Lane</u> - The Board of Supervisors agreed to schedule a meeting with the property owners of Burgundy Lane to be held on Monday, November 20, 2017 at 6:30 p.m. and directed township staff send a letter to all Burgundy Lane property owners notifying them of the meeting.

APPROVAL OF MINUTES:

SOLICITOR'S REPORT:

Mr. Jarvis reported on the following:

- Mr. Jarvis noted that he reviewed the Valley & Hillview documents.
- Mr. Jarvis noted that he discovered the deed for the transfer of 1230 Valley Road from Michael Pia to Valley Township, was filed by Mr. Pia's representative.
- Mr. Jarvis reported that he conducted lengthy discussions with Mr. Ellis, Pennoni Associates, regarding the Valley Suburban plan.
- In regard to township acquisition of tax parcel 38-5-15, Mr. Jarvis reported that after corresponding with the title company regarding possible well and cesspool easements on the property, further review ultimately deemed the easements were on a different parcel and this parcel was free of easements.

Ms. O'Doherty made a motion to proceed with acquisition of parcel 38-5-15 not to exceed a total cost of one thousand three hundred dollars (\$1,300.00). Mr. Lama seconded the motion. Question: Mr. Lehenky – yes; Ms. O'Doherty – yes; Mr. Lama – yes; Ms. Proctor – yes.

- Mr. Jarvis stated that resolutions necessary for the township to enact Fire and Ambulance taxes have been drafted.

 the deficiencies. He will be returning the contracts to Mr. Dillon for correction of
 deficiencies.
- Mr. Jarvis stated that he is in receipt of the zoning application for Hughes, Mineral Springs Road.

Mr. Rasiul read and submitted the engineer's report which will be on file at the Township Office.

<u>Discussion/consideration to authorize Change Order #1 for the 2017 Road Program Project</u> - **Mr.** Lehenky made a motion to authorize Change Order #1 for the 2017 Road Program Project in the amount of \$6,375.05 based on as-built quantities. Ms. O'Doherty seconded the motion. Question: Mr. Lehenky – yes; Ms. O'Doherty – yes; Mr. Lama – yes; Ms. Proctor – yes.

<u>Discussion/consideration</u> to authorize payment #1/Final payment to D. Malloy Paving — Based on the Engineer's recommendation, Mr. Lehenky made a motion to authorize payment #1/final payment to D. Malloy Paving in the amount of \$128,546.60 for the 2017 Road Project, with \$121,457.10 paid from Liquid Fuel Fund, and \$7,089.50 from the General Fund. Mr. Lama seconded the motion. Question: Mr. Lehenky — yes; Ms. O'Doherty — yes; Mr. Lama — yes; Ms. Proctor — yes.
