MINUTES FOR JANUARY 4, 2021 – REORGANIZATION MEETING VALLEY TOWNSHIP BOARD OF SUPERVISORS

The annual Reorganization meeting of the Valley Township Board of Supervisors was held on Monday, January 4, 2021, via virtual meeting through *Go To Meeting*. All Board members were present. The meeting was called to order by Supervisor Kathy O'Doherty who asked for a moment of silence to include thoughts for Jamie Sauer, daughter of Emergency Management Coordinator/past Township Supervisor Joe Sciandra, who tragically lost her life in an automobile accident yesterday.

It was noted that the meeting was being conducted through *Go To Meeting* to comply with Governor Wolf's order that all individuals in Chester County stay home in an effort to slow the spread and minimize public exposure to COVID-19 and maintain social distancing.

NOMINATIONS FOR CHAIRPERSON

Ms. O'Doherty nominated Patrice Proctor for Chair of the Board of Supervisors. Mr. Lehenky seconded the nomination. There being no other nominations for Chair, nominations were closed. Ms. Proctor was unanimously elected as Chairperson of the Board of Supervisors.

NOMINATIONS FOR VICE CHAIRPERSON

Mr. Lehenky nominated Kathy O'Doherty for Vice Chair of the Board of Supervisors. Ms. Yates second the nomination. There being no other nominations for Vice Chair, nominations were closed. Ms. O'Doherty was unanimously elected as Vice Chairperson of the Board of Supervisors.

At this time, Ms. Proctor took over to run the meeting.

APPOINTMENTS

<u>Township Manager</u> – Ms. O'Doherty made a motion to appoint Scott Piersol as Township Manager effective January 19, 2021, contingent upon satisfactory completion of his background/credit check, physical/drug screening; and management contract in place. Mr. Lehenky seconded the motion. The motion passed unanimously.

<u>Assistant Township Manager/Secretary</u> – Ms. Yates made a motion, seconded by Ms. O'Doherty, to appoint Janis Rambo as Assistant Township Manager/Secretary. The motion passed unanimously.

<u>Treasurer</u> – Ms. O'Doherty made a motion, seconded by Ms. Yates, to appoint Peter Barsz as Interim Treasurer/Assistant Treasurer. The motion passed unanimously.

<u>Chief of Police</u> – Ms. O'Doherty made a motion, seconded by Ms. Yates, to reappoint Brian Newhall as Chief of Police until his resignation date of January 8, 2021. The motion passed unanimously.

<u>Solicitor</u> – Mr. Lehenky made a motion, seconded by Ms. Yates, to reappoint Unruh Turner Burke & Frees as the Township Solicitor. The motion passed unanimously.

<u>Engineer</u> – Mr. Lehenky made a motion, seconded Ms. O'Doherty, to reappoint Pennoni Associates Inc. as the Township Engineer. The motion passed unanimously.

<u>Roadmaster</u> – Ms. Yates made a motion, seconded by Ms. O'Doherty, to reappoint Kris Lenhart as Roadmaster. The motion passed with Mr. Lehenky voting nay as he believed this was to be Mr. Lenhart's title and for him to be annually appointed.

<u>Building/Code/Zoning/Plumbing/Mechanical/Electrical Official</u> – Ms. Yates made a motion, seconded by Ms. O'Doherty, to reappoint LTL Consultants, Ltd., as the Building/Code/Zoning/Plumbing/Mechanical/Electrical Official. The motion passed unanimously.
