2024 CONTRACTORS INSURANCE REGISTRATION

Contractors must register with Valley Township if any of the following applies:

- 1. You build new homes or subcontract with a builder of new homes.
- 2. You serve as a contractor or subcontractor on any commercial project.
- 3. You are not registered with The Bureau of Consumer Protection of the Office of the Attorney General of the Commonwealth of Pennsylvania.
- 4. You earned less than \$5,000 the prior taxable year.

All plumbers must register with Valley Township as a Master Plumber or Journeyman.

If any of the above applies to you, please complete the enclosed registration form and return with your payment by January 15, 2024.
