TRASH FEE & BILLS

Effective January 1, 2024, the quarterly trash fee will be \$85.00. The first
quarter bill for 2024 will be due in April. Trash bills for the fourth quarter of
2023 were mailed on December 29, 2023. Discount is due on January 16
and face amount is due January 31.

ANNUAL TAX RATE

The annual tax for general Township purposes will remain the same at 2.75
mills, EMS will remain the same at 0.50 mills and Fire will increase to 1.25
mills for a total of 4.5 mills.

PERMIT & NON-PERMIT FEE INCREASES
