### COMPOST SITE OPEN:

Saturday, October 9 from 8:00 am to 2:00 pm. The Central Chester County Recycling Authority Compost Site is located at 2240 Upper Gap Road, Coatesville. Identification required. Items accepted are leaves, vegetables, garden clippings, weeds, brush and limbs.

### LEAF COLLECTION:

November 1, 8, 15, 22 & 29

We collect rain or shine; leaves must be placed in bio-degradable paper collection bags. No plastic, trash, sticks and other debris should be mixed in the bag.

### UTILITY BILLS:

The third quarter Water/Sewer/Trash bills were mailed on September 30, 2021. They are due by November 1, 2021 at the close of business; the discount period ends on October 15, 2021, at the close of business. The drop box will be check at 4:00 p.m. before the office closes. Anything placed in the box after that time is stamped as being received the next business day.

We do look at postmark dates for those that mail in their payment and will honor the date of the postmark. Please note, if you request your bank to issue your payment and mail it in, these third-party vendors/banks mail via a first-class presort that does not get postmarked; therefore we must go by the day we receive the payment. Please plan accordingly.

With the upcoming sale of the water and sewer systems to Pennsylvania American Water, at this time it is anticipated that a final Valley Township meter reading may be done on November 8 and 9; therefore a pro-rated final bill for water and/or sewer for those residents who currently are on the Township's system, will be receiving a final invoice from Valley Township for water/sewer mid to late November. The fourth quarter trash bill will be sent out as normal by January 1, 2022.
