B. Project Updates

- 1. Valley Crossing Stormwater Basin retrofit: The 2 Easement documents are being prepared for signing by all parties. The project will go out to bid as soon as the easements are executed. Construction over the summer and planting/seeding in fall. (CBDG)
- Bradley Ave Bridge: will be going out to bid and the precast concrete bridge structure will be fabricated and shipped to the site. Same precast as the 2020 Hemlock Bridge Replacement (across from Westwood Fire Company) CBDG
- 3. South Park Ave Bridge over Sucker Run Tributary: Currently posted as 3 ton maximum. EMC, Joe Sciandra is working with FEMA/PEMA on funds for Replacement of the Bridge.
- 4. Glencrest/Rd Millview Basin with Coatesville. The County is coordinating planning meetings with Valley & Coatesville and their engineers. Valley project is ready to bid. Coatesville/Millview needs to obtain signatures from Chetty builders and the Millview HOA.
- 5. Wagontown Rd: Pennoni Engineering is working on a fee agreement with PennDot for design of project.
- 6. Hillview Basin Outflow EMC & Pennoni and FEMA/PEMA for the specifications for the supplies (stone)
- 7. Second Ave/Lincoln Highway Storm water Grant: No news yet. Expecting in next few weeks.
