#### **GENERAL COMMENTS**

- Drop off recycling of electronics at the Township Building during normal business hours. Television collection (prepay for collection) is the last Monday of each month; televisions can be dropped off at Township Building <u>please note you must be able to lift and carry in the television</u>. Residents can also take **three** televisions per vehicle to the Chester County Solid Waste Authority Landfill (Route 322, west of Honey Brook) as well as a <u>small</u> electronic drop off site. Both the CCSWA and the Township drop off will accept <u>small</u> electronic items such as computer cables/wires, stereos, radios, cameras, video cameras, tape recorders, VCR/DVD.Blu-ray, video game systems, MP3 players, handheld computer devices, disk drives, calculators, answering machines/telephone systems, satellite receivers/descramblers, projectors, anything with a plug or circuit board, blenders (no glass), coffee maker/Keurig (no glass), blow dryers, curling irons. <u>You must be able to carry your items into the building</u>. No large appliances or microwaves.

- Compost site open November 11, 2023 from 8:00 a.m. 2:00 p.m.
- Mattress & TV collection October 30, 2023 pre-paid fees apply

- Debit/credit card payments are now being accepted in the office and trash payments are online only (processing fee applies)
- 3Q trash bills were mailed out and payment is due by 4:00 p.m. on October 31, 2023
- Trick or Treat is set for October 31, 2023 from 6:00 p.m. to 8:00 p.m.
